Meaningful Use in Five Years

ABSTRACT

This presentation will include a discussion of Hospital and Health Systems challenges in adopting, implementing and upgrading their electronic medical record systems to achieve meaningful use and the resulting practical challenges that impact the Hospital or Health Systems operations. The Hospital and Health System executives will also review how information technology has changed from a potential tool for data collection to an instrument that is part of the integrated delivery of healthcare services by providing examples and discussing the day to day impact on the Hospital and Health Systems strategic plans. This presentation will also review the increased importance of information technology as a critical element to how the healthcare delivery system and payment reform models are being structured. The discussion will include a review of the recent payment changes that have been created through the Patient Protection and Affordable Care Ac ("Healthcare Reform") and the importance of information technology in implementing the payment reform models.
